

2022 Spring Crappie Classic Fishing Tournament Entry Form

Saturday, April 2nd at Alamo Lake

Rules:

- 1) All State of Arizona, Arizona Game & Fish Department, Alamo Lake State Park, and United States Government laws and regulations must be followed. Failure to comply with said laws and regulations along with the rules of this event might result in forfeiture of any money paid and disqualification from the event.
- 2) This event does not include parking or camping fees. Everyone is responsible for obtaining the appropriate pass.
- 3) Signed tournament entry forms with rules and regulations will be taken as well as live well checks at the Cholla Boat Ramp gravel parking lot area (see picture on last page) starting at 5:45am. Tournament begins at 6 am from the Cholla Boat Ramp gravel parking lot. After your entry form has been taken and live well checked, the tournament director will indicate approval to launch and begin fishing at 6am. The tournament director will take entries up until 6:30am.
- 4) Heaviest bag of 7 Crappie per team wins. You will be allowed keep all the fish you want but you can only weigh in 7 fish. All Crappie weighed and/or kept at this event must be at least 10 inches in length. Any Crappie caught smaller than 10 inches must be immediately released. In case of a tie on total weight, the weight of the largest crappie will be used to break the tie.
- 5) A 4-pole limit per team, you can have up to 4 people on your team but only 4 poles in the water at a time. One team per boat.
- 6) Hook and line, live bait and trolling are permitted.
- 7) A Side Pot of \$40 per team (exact change, cash only) will be offered. Side Pot money must be paid when you enter. 1st place wins 50% of the Side Pot, 2nd place wins 30% and 3rd place wins 20%. Only teams entered in the Side Pot can win.
- 8) \$20 per team (exact change, cash only) "Wild Willie Big Crappie Option" will also be offered. Option money must be paid when you enter. The heaviest Crappie caught wins the option money. Only those teams entered in the "Wild Willie Option" can win.
- 9) A single event fee of \$15 per team will be charged. This fee helps pay for event liability insurance, trophies, and other costs associated with the fishing tournament and is not paid back in tournament winnings.
- 10) You must check-in for weigh-in by 3:00 pm at the Alamo Lake D-Loop Campground (see picture on last page). When you arrive at weigh-in you must check in with the Tournament Director and have your fish ready to weigh. The Tournament Director will start accepting check-ins for weigh-in at 2:30pm if you'd like to arrive earlier.
- 11) There will be a one-pound penalty for each 5-minute period you are late for 3:00pm weigh in. Any team that arrives at the weigh-in after 3:10 pm cannot weigh in fish. All teams entered in on the "Side Pot" and/ or the "Wild Willie Option" must be at weigh in by 3:10 pm to claim any prizes.
- 12) The announcement of tournament winners and presentation of trophies will occur at the Alamo Lake D-Loop Campground, immediately before the AZCA meeting.

RELEASE AND EXPRESS ASSUMPTION OF RISK AGREEMENT

In consideration to participate in any way in the event on the reverse side, I agree and acknowledge:

1. Release: I personally and on behalf of my heirs, successors, servants, assigns, executors, administrators, guardians and conservators, HEREBY, DISCHARGE, CANCEL, WAIVE, COVENANT NOT TO SUE, ACQUIT AND HOLD HARMLESS the State of Arizona, the Alamo Lake State Park, the United States Government, the Arizona Crappie Association, and its partners, employees, principals, agents, servants, heirs, administrators, successors, shareholders, directors, officers, representatives, and attorneys. As well as any governmental entity where the Events are held, and agree to hold them free and harmless for, from, against any character whatsoever, whether known or unknown, suspected or unsuspected, arising from their negligence or otherwise, including but not limited to, all liabilities for personal injury, property damage or wrongful death caused by such negligence or otherwise (the "Claims").

2. Indemnification: I also agree to indemnify and defend the Arizona Crappie Association, the State of Arizona, the Alamo Lake State Park, and the United States Government against the claims, and other damages, costs and expenses, including reasonable attorney's fees, resulting from any Claim made by me or my agents or successors-in-interest. I understand and agree that under this provision, the Arizona Crappie Association, the State of Arizona, and the United States Government will be indemnified by me whether the Arizona Crappie Association's, State of Arizona's, or the United State Government's potential liability for Claims has risen as a result of the Arizona Crappie Association's, State of Arizona's, or the United States Government's negligence alone, or of co-negligence with me, or the negligence of others.

3. Assumption of Risk: I acknowledge that these Events involves certain risks and hazards, including the risk of accidental injury or death, or loss or damage to property, resulting from wild animals, inclement weather, accidents, equipment malfunctions, collisions, falls, drowning, equipment and gear, related injuries (such as fishing hooks in fishing events) or other causes. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE ARIZONA CRAPPIE ASSOCIATION, THE STATE OF ARIZONA, OR THE UNITED STATES GOVERNMENT or others, and assume full responsibility for my participation in these Events.

4. Good Health & Expertise: I attest and verify that I am physically fit, am enjoying good health and have sufficient expertise for participation in these Events. I understand that fishing is a physically strenuous activities and that I will be exerting myself during these Events, and that if injured as a result of a heart attack, panic, hyperventilation, etc. That I expressly assume the risk of said injury.

5. Publicity: I also irrevocably authorize Arizona Crappie Association, the State of Arizona, the Alamo Lake State Park, and the United States Government, and any assignee to use my name, voice, likeness, biographical information, and/or tips in photography, audio, video, or any other format for publication, advertising, promotional or any other purposes, without restrictions as to changes or alterations from time to time. I understand that I will not be entitled to receive any royalties or other compensation in connection with such use.

6. Rules: I take responsibility to know the rules for Arizona Crappie Association's fishing tournament and follow the rules. I ACKNOWLEDGE THAT I HAVE CAREFULLY READ, UNDERSTAND, AND AGREE TO ALL CONDITIONS AND TERMS SET FORTH IN THIS AGREEMENT. I have carefully read this statement. I understand that it is a LEGALLY BINDING AND ENFORCEABLE CONTRACT. I SIGN OF MY OWN FREE WILL and I intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

I have read the above rules & regulations for the 2020 Bob Hirsch Crappie Classic Fishing Tournament and agree to follow said rules & regulations as stated above. I understand that failing to comply with said rules and regulations may result in my team being disqualified from the event and forfeiture of any moneys paid. I also understand that the Arizona Crappie Association, State of Arizona, and the United States Government does not insure or guarantee my or my team's personal safety or the welfare of any personal property. Therefore, I take full responsibility for the safety and actions of my team members and myself and relieve all organizers of the 2020 Bob Hirsch Crappie Classic Fishing Tournament, the State of Arizona, the United States Government, the Arizona Crappie Association, and its officers and membership of any and all liability that may become from participating in this event.
